## TERMS OF SERVICE:

- It is understood that Valley Photography is the exclusive official Photographer(s) retained to perform the photographic services requested on this Contract.
- Valley Photography may substitute another Photographer to take the photographs in the event of Photographer' s illness or of scheduling conflicts. In the event of such substitution, Valley Photography warrants that the photographer taking the photographs or video shall be a competent professional.
- No part of any order, including previews, will be delivered until the balance is paid in full.
- A Travelling / Lodging Fee will be applied to any events photographed outside the greater Saint John area. The Fees are as follows: Southern New Brunswick - \$150, Central New Brunswick - \$200, Northern New Brunswick - \$250, Northern Nova Scotia - \$200, Southern Nova Scotia \$250, Cape Breton - \$250, Prince Edward Island - \$250 plus current Confederation Bridge toll fee.
- Valley Photography retains ownership of all files and images with the right to use digital files and/or reproductions for advertising, display, publication or other purposes. Clients will be given rights to use images without restriction for personal purposes.
- Images are edited at the Photographer' s discretion, and delivered packages may not include all images shot. The Photographer reserves the creative rights to edit and release only those images deemed creditable as professional in quality and within the Photographer' s artistic standards. No RAW or unedited images will be provided to the Client for any reason.
- If the Photographer(s) cannot perform this contract due to fire or other casualty, strike, act of God, or other cause beyond the control of the parties, or due to Photographer' s illness or emergency, then the Photographer shall return any fees paid to the Client but shall have no further liability with respect to the contract. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost through equipment malfunction, lost in the mail, or otherwise lost or damaged. In the event the Valley Photography fails to perform for any other reason, Valley Photography shall not be liable for any amount in excess of the fees paid by the Client.
- Due to the unpredictable nature of the photography industry, Valley Photography does not guarantee delivery date / time of any printed materials, digital files, DVDs or any other photographic materials related to this agreement, and any time frame provided is strictly an estimate.
- Valley Photography requires a minimum two hour window to photograph the formal images during a wedding. Should we be given less time, the Client fully understands this could negatively impact the quantity and / or quality of the images created.
- Harassment of any kind, including but not limited to, verbal, physical, psychological abuse will not be tolerated. Coverage of the event will cease immediately should the Photographer(s) feel they are being harassed in any such manor. Client will forfeit payment in such an event.
- It is the responsibility of the Client to organize and present people and items they wish to have photographed (Ie family, rings etc..) The Photographer(s) will not be responsible for any people or items missed due to lack of time or organization on the part of the client.
- During the dinner portion of the event each Photographer(s) must be given one of the following: A meal provided by Client OR One Hour of idle time in which the Photographer(s) may be permitted to leave the premises to obtain a meal. This time is to be included in the total working hours of the Photographer(s) and Valley Photography accepts no liability for events not photographed during this time period.
- Client is aware that color dyes in photography may fade or discolor over time due to the inherent qualities of dyes, and Client releases Photographer from any liability for any claims whatsoever based upon fading or discoloration due to such inherent qualities.
- Client is aware that Photographer(s) is bound by the rules of the location in which the ceremony is held and that said rules may negatively impact the quality of the images. (No flash permitted, limited shooting opportunities, restrictions on Photographer movement etc..)
- The charges in this Contract are based on our standard price list. This price list is adjusted periodically and future orders shall be charged at the prices in effect at the time when the order is placed.
- To reserve the Session Date, Client shall pay to Photographer, upon execution of this Agreement, a non-refundable reservation fee in the amount of \$400.00. Client understands and agrees that Photographer will not book other sessions during this time. In the event that the Client cancels the session or fails to attend the session on the Session Date, for any reason, the Photographer shall suffer losses that are difficult to ascertain. As such, Client agrees that, in the event of cancelation by Client, such \$400 shall be forfeited by Client and paid to Photographer as payment against loss of income caused by cancellation, and not as a penalty. Client and Photographer agree that such amount is reasonable.
- This Contract incorporates the entire understanding of the parties. Any modifications of this Contract must be in writing and signed by both parties.
